General terms and conditions of sale and conditions of ICH WOTTS WÜSSE

Sales transaction

By purchasing a ticket, you conclude a contract with ICH WOTTS WÜSSE for the services described in more detail on the ticket and in the description on the ichwottswuesse.ch website. The tickets, including or without ancillary services, are issued in the name of the buyer and are tied to this person and not transferable. The ticket holder has the right to purchase the services as shown on the ticket, provided that the entry requirements are met. Access restrictions - in particular the compulsory submission / presentation of a Covid certificate - apply without restriction, provided that this is required by the federal government, the BAG or the organizer. It is the sole responsibility of the buyer to place orders for admission tickets in good time before the date of the event via the web shop or one of the Ticketino advance booking offices. There is no box office. In the event of errors in the ticket distribution system, transmission errors, technical malfunctions or unlawful interventions by third parties, the organizer will refuse any guarantee.

Disclaimer of Liability

To the extent legally permissible, ICH WOTTS WÜSSE excludes liability for damage that you suffered in connection with the event before, during or after attending the event, regardless of whether this damage was caused by the organizer, the organizer's assistants or third parties have been caused from. ICH WOTTS WÜSSE is solely responsible for the quality of the services and the event. If ICH WOTTS WÜSSE is not the organizer myself, any claims on your part must be made to the organizer.

Ticket-Sales

The organizer ICH WOTTS WÜSSE shows all fees transparently on their website. There are no separate advance booking fees. Direct purchases at the counter or online via the ticket shop are made by Ticketino.ch and their advance booking offices. There will be no ticket sales at the event.

The tickets will only be sent by e-mail with a download link or attached print-at-home ticket following payment. You can independently print out your tickets in the same size with a suitable printer on white A4 size paper. You can also show the ticket with the QR code digitally on your smartphone. If a print-at-home ticket shows damage, soiling or other impairments that make the information on the ticket and / or the barcode illegible, there is no entitlement to admission to the event and / or to a refund of the purchase price. This also applies to the display on the smartphone or if it is not possible to present it with a smartphone because the battery is empty. For your security, you have a ticket number on the ticket which can be edited manually at the entrance. However, this can lead to longer waiting times for you.

Each purchased and paid ticket includes only one access authorization for the person listed. Any duplication, copy, modification or imitation of the print-at-home tickets and any electronic dissemination of the corresponding data is expressly prohibited and can be prosecuted. ICH WOTTS WÜSSE reserves the right to refuse entry to the event if several printouts, reproductions, copies or imitations of a print-at-home ticket are in circulation and a holder of a print-out, copy or imitation has already been granted access to the event.

In particular, ICH WOTTS WÜSSE is not obliged to check the identity of the ticket user. In addition, there is no entitlement to repayment of the ticket price whenever entry to the party has been denied for reasons mentioned above.

Check your tickets at delivery

You are obliged to check the tickets you have ordered immediately upon receipt. If the data on the admission tickets are damaged or do not correspond in all details to the tickets you have ordered, you must inform ICH WOTTS KÜSSE within 3 working days. Complaints after this period can no longer be considered and the tickets are considered approved (Art. 201 OR).

General conditions

Postponing an event

If an event has to be postponed by ICH WOTTS WÜSSE, a ticket remains valid. In this case, ICH WOTTS KÜSSE alone decides on a return, refund or exchange of a ticket

Obligations and liability of the ticket buyer

Safety and Implementation Regulations

By purchasing the ticket, you accept the security, access, age and other implementation regulations of ICH WOTTS WÜSSE. You also acknowledge that if you fail to comply with the regulations and conditions, you can be excluded from the event without compensation. The applicable regulations are available from the respective organizer.

Reproductions of Events

While attending the event, any sound, photo, film, radio, television and / or other reproducible recordings inside the event are prohibited unless I KNOW and, if not identical, also the organizer has given prior written consent to such recordings.

Resale and Promotion

Trade and Resale

Any commercial or commercial trade with purchased tickets is prohibited. Violations can lead to the loss of the services associated with the purchased tickets and to claims for damages. Persons who violate these provisions can be excluded from future ticket purchases.

Advertising and Raffle

Without the express prior consent of ICH WOTTS WÜSSE it is not permitted to use tickets in advertising aimed at the general public or for raffles.

Adjustments to terms and conditions

ICH WOTTS WÜSSE reserves the right to change its terms and conditions at any time. Changes are made accessible on the webshop and come into effect when they are activated. For contracts with ICH WOTTS WÜSSE, the terms and conditions currently valid on the day the contract is concluded always apply. These remain in effect for the corresponding contract even if the terms and conditions are changed at a later date.

Other regulations

ICH WOTTS WÜSSE reserves the right to set a purchase quota (number of tickets per person) for tickets. Admission to the event differs depending on whether a dinner was purchased as an additional service or only admissions to the party is included. Dinner starts at 6:00 p.m. and lasts until 9:00 p.m. If you arrive after this period, the entitlement to the additional service booked expires, but not to the event attendance.

Personal Data

Personal data that is collected or viewed for the issue of the ticket or when the ticket is presented as part of the Covid certificate control can only be passed on to third parties and used in the context of tracking contacts in the case of registered / reported infections

Place of Jurisdiction

The ticket buyer recognizes Zurich ZH as the exclusive place of jurisdiction for all legal disputes in connection with the ticket order or services from ICH WOTTS WÜSSE.

Final Provisions

Should a provision of these sales conditions be or become ineffective or the contract contain a legally inadmissible formulation, the legal validity of the remaining provisions shall remain unaffected. Instead of the ineffective provision, an effective provision is deemed to have been agreed which comes closest to the economic intent of the parties.

Unless otherwise agreed in these General Terms and Conditions, the provisions of the Swiss Code of Obligations apply.

With the conclusion of the purchase contract by selecting and paying for the booked tickets, you accept these conditions of sale.
